SPECIAL GOVERNANCE SECTION: APPLICATION FEES AND MEMBERSHIP DUES

(revised and updated April 26, 2019)

Application Fees and Dues – All payments in one check are made payable to MTSSAR.

Please refer to Appendix A for a specific breakdown of the dues and fees.

1. The non-refundable application fee is **\$160.00** (as of January 1, 2019) payable at the time of application to join the National SAR: \$115.00 to National and \$45.00 to MTSSAR and the Chapter.
2. The non-refundable application fee shall be for each additional applicant on the Family Plan application on the same patriot is **\$90.00** - \$65.00 to National and \$25.00 to MTSSAR.
3. The non-refundable application fee for relatives of SAR, DAR and CAR, ages 18 through 24, is **\$90.00** - \$65.00 to National and \$25.00 to MTSSAR.
4. The non-refundable application fee shall be for a Junior applicant under 18 years of age on the same family line is **\$60.00** - \$35.00 to National and \$25.00 to MTSSAR.
5. The annual dues for Montana SAR Regular Members are **\$60.00** payable before January 1 of each calendar year, which includes National, MTSSAR and Chapter dues: \$35.00 to National, \$20.00 to MTSSAR and \$5.00 to the Chapter.
6. The annual dues for Junior Members of the Montana SAR are **\$5.00** (five dollars) payable before January 1 of each calendar year, which includes chapter dues.
7. The annual dues for Dual Members of the Montana SAR shall be the same as Regular Members. Dual Members shall be assigned to a chapter by the Montana SAR Secretary based on the members choice whenever possible.
8. Adjustments to either the application fee or membership dues can be made at Annual Meetings without a formal amendment to this section of the document.
